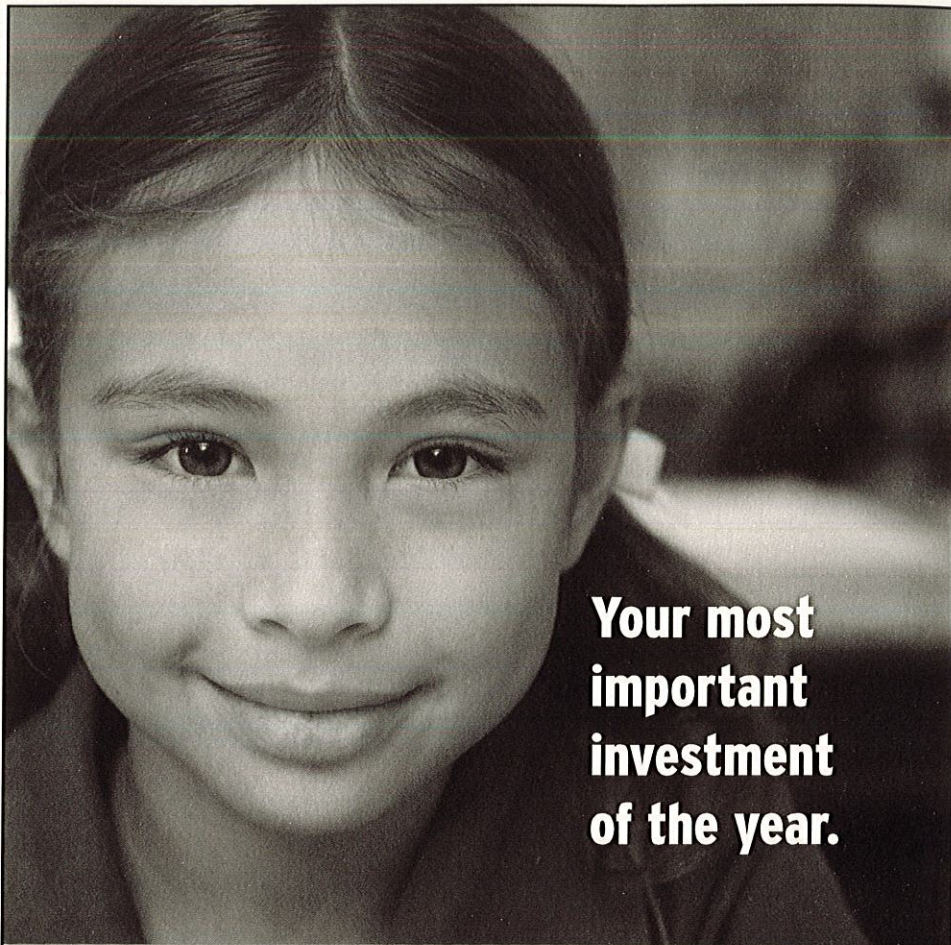

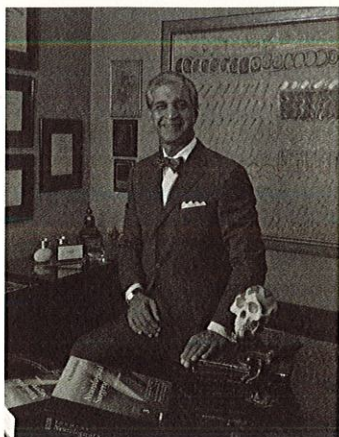

## DR. ANIL NANDA



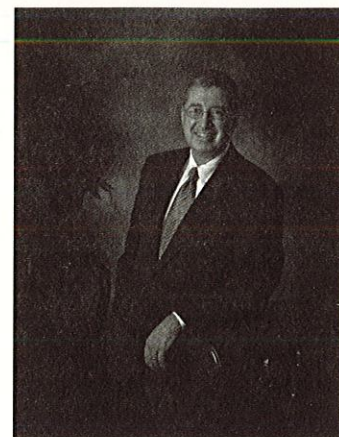
Dr. Anil Nanda is Professor and Chairman of the Department of Neurosurgery at LSU Health Sciences Center in Shreveport. Appointed Chief of Neurosurgery in 1990 and then the first Neurosurgery Department Chairman with its establishment in 1995, Dr. Nanda has ushered the growth and development of University Neurosurgery through the vision he continues to share with the department's faculty and staff. In spring of 2002, Dr. Nanda successfully established accreditation of a neurosurgery residency program at LSUHSC in Shreveport, the first such residency program to be approved in the last five years. In summer of 2005, Dr. Nanda successfully obtained full accreditation and received an increase in residents per year. Currently, the Department of Neurosurgery is one of the busiest in the south with over 2,800 cases this past year.

Committed to the expansion of higher education, Dr. Nanda has been the invited guest lecturer and visiting professor at over 70 national institutions and international venues. He has also published articles in neurological journals on many areas including his primary interests: aneurysms, AVMs, and skull base tumors. He has over two hundred peer review publications and two books. In addition, Dr. Nanda continues to promote the importance of safety and prevention to both adults and children through his involvement in local community service efforts. His efforts have been acknowledged and rewarded both on a local and national level, having received the Living Legend Award in 1996 and named among the Best Doctors in America consecutively from 1996 to 2010.

Dr. Nanda has served as President of the Society of University Neurosurgeons (2010-2011), Southern Neurosurgical Society (2006-2007), Louisiana State Neurosurgical Society (2005-2007), and North American Skull Base Society (2005-2006). He is also a member of the American Medical Association, the American Association of Neurological Surgeons, the Congress of Neurological Surgeons, the Louisiana State Medical Society, and the Shreveport Medical Society.

A native of New York, Dr. Nanda earned his medical degree with honors from Madras University in 1982. He then served an internship in surgical oncology at the Sloan-Kettering Research Center in New York, and residencies in general surgery at Rush Presbyterian-St. Luke's Hospital in Chicago and in neurosurgery at Hahnemann University School of Medicine in Philadelphia. He then completed fellowship training in microneurosurgery and cranial base surgery at the University of Pittsburgh in 1990. He recently completed his Master's in Public Health core curriculum at Harvard University's Harvard School of Public Health and will graduate in May 2012. Dr. Nanda is married to Laura Nanda, an attorney, and has three children; Alexander, Christopher, and Mary Catherine.

## DR. PHILIP ROZEMAN



Dr. Phillip Rozeman is the President and founding physician of Cardiovascular Consultants – the largest cardiology group in the Ark-La-Tex region – and a pioneer in the region in several new cardiac technologies including coronary stent and dual chamber pacemaker implantation. He has been honored by the Consumer Research Council as one of America's Top Cardiologist and named one of the "most influential physicians in NW Louisiana" by USA Today.

He was born in Shreveport and graduated Magna Cum Laude from LSU-Shreveport and was in the top 5 of his graduation class at LSUHSC in Shreveport. He trained at the Medical University of South Carolina in Internal Medicine, Cardiology, and Interventional Cardiology and is board certified in all three specialties.

He has served in many healthcare leadership positions at Willis-Knighton Health System including Chief of Internal Medicine, Chief of Staff, Medical Executive Committee, and the WK Board of Trustees. He served as Chairman of the Governor's Regional Healthcare Consortium under Governor Blanco and medical director of NW Louisiana Red Cross beginning with the organization of medical care for Hurricane Katrina/Rita evacuations.

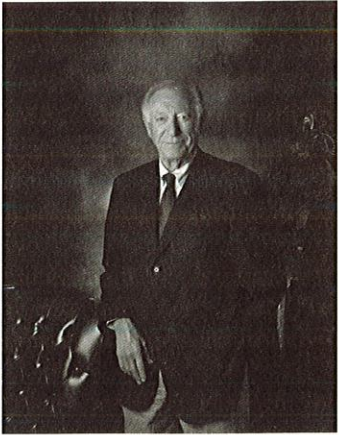
Dr. Rozeman is founder and first board chairman of the Alliance for Education, Education's Next Horizon, and the SB Imperative – all non-profit organizations that connect business and education leaders around school improvement. He is president-elect of Blueprint Louisiana, LSU-S Foundation and Shreveport Medical Society and currently serves on the executive board of the state Committee of 100, NW Louisiana United Way, and Greater Shreveport Chamber of Commerce. After taking a leadership role in the development of the Caddo-Shreveport Master Plan, he continues service as co-chair of the Community Advisory Group.

Dr. Rozeman has been named Business Leader of the Year by both the Greater Shreveport and Minden Chambers of Commerce as well as Citizen of the Year by the March of Dimes. He has been honored with the annual community service awards of the NW Louisiana and Acadiana United Way, Louisiana State Medical Society, Shreveport Bar Association, Blue Cross Blue Shield Angel Award, Louisiana Association of Educators and Louisiana Department of Education. He has been named LSU-S Alumnus of the Year and 2010 Pilot of the Year and was chosen by the Times in the first group of ten people nominated as "Community Leaders Who Make a Difference" in the new millennium.

Dr. Rozeman is active in his church as a deacon and participates in a medical mission effort in southern Mexico every year. He has celebrated 33 years of life together with Alma Pineda Rozeman. They have three children – Laura, Sarah, and Mark – all who have been successful in their own undertakings.



## MR. H.E. "BUD" STORER



Hubert Storer was born in Malvern Iowa, attended school in Creston Iowa and graduated from Creston High School in 1950. He is a veteran of the United States Air Force and an Industrial engineering graduate of the University of Iowa. Upon graduation he continued his education in a post graduate training program of The Trane Company in La Crosse Wisconsin.

Upon completion of the Trane Student Class Bud was assigned to the New Orleans Sales Office in the summer of 1959. He agreed to assignment in Shreveport as Trane's sole representative in North Louisiana and East Texas in 1962. Business grew and in 1967 Mr. Storer was awarded a Shreveport Trane Franchise to represent Trane as an independent agent. The business was incorporated in 1972 as Storer Equipment Company Inc.

Today Storer Equipment employs over ninety full time associates working in equipment sales, parts, service, controls contracting and facilities management. Bud Storer is Chairman and Chief Executive Officer, son Craig is President and Chief Operating Officer, grandson Aaron Storer, home from Marine duty is now active in the business specializing in controls and building energy saving strategies.

Mr. Storer is a past president of the National Association of Trane Franchise Holders and has served on its board and numerous committees. Locally he is involved in service at the First United Methodist Church having served as Chair of Finance Committee, Chairman of the Church Council and is presently a member of the Building committee and Chairman of the Facilities Improvement Team. Other associations include board membership past and present of Methodists Children Home, Chamber of Commerce, American association of Heating Refrigeration and Air Conditioning Engineer, Shreveport Bossier Executive Association, Shreveport Rescue Mission, LSUS Foundation, Committee of 100 and Caddo Career and Technology Center.

Bud is a president's club member of the Iowa University Alumni Association. Several years ago he endowed an annual award to winners of an entrepreneurial contest for engineering students in his name. Several new companies have been started with initial expenses funded by the University of Iowa from Hubert E. Storer Entrepreneurial Award. Wife Martha is a graduate of Louisiana Tech. She and Bud enjoy active participation in Tech Alumni Association activities and support of its mission.

Past awards or recognition include "2005 Samaritan of the Year Award" by the Samaritan Counseling Center, Better Business Bureau "2008 Torch Award for Ethics in Business", and "2009 Outstanding Philanthropist" by the North Louisiana Association of Nonprofit Organizations.

Mr. Storer married Jacqueline "Lynne" Hooke (deceased) of London England while serving in the USAF in 1953.. He and Lynne had four children, Laura, Craig, Mark and Sheryl. Mr. Storer married again to Martha D. Allbritton of Shreveport in 1980 and has three step children Linda Hughes, O.C. Allbritton Jr. and Amy Wilson. Together Bud and Martha have seven children, twelve grandchildren and two great grandchildren. Bud enjoys sports, travel and the satisfaction of seeing young people learn and succeed in business.

## BUSINESS HALL OF FAME CRITERIA FOR LAUREATE NOMINEES

Achievement in one or more of these categories:

- Outstanding overall business achievement
- Outstanding achievement of national impact
- Outstanding achievement in "small business"
- Outstanding leadership in public service and/or philanthropic activities

Economic impact in Louisiana during the time the other criteria were made

Recognition by his or her organization or profession to have made a significant contribution to the success of the organization or profession

Ability to serve as a role model for the young people of North Louisiana

Recognized as observing high moral and ethical principles

Accomplishments of landmark proportions, significantly influencing his or her organization, industry, and community

A record of outstanding entrepreneurial achievement

Accomplishments of a continuing nature (as opposed to a one-time effort)
