MR. RAND H. FALBAUM



Mr. Rand H. Falbaum, Shreveport-born, graduated from Captain Shreve High School in 1976, Texas A & M University in 1980 and University of Texas at Austin in 1982. In 1984, he received CPA designation. He enjoyed a banking career in Dallas until

returning home in late 1985 to become President of Gordon, Inc.

Mr. Falbaum is a local real estate developer and operator with a number of real estate interests, including five self storage facilities. He also has numerous industrial, office and retail properties. Mr. Falbaum has expanded his business interests into the ownership, management and mentoring of a number of businesses in Louisiana, Kansas and Texas including Shoppes at Bellemead, Ashley Ridge and the new Home Design Center. He is co-owner of Sound Fighter Systems, Stone America, CRM Studios, PODS, Direct Buy, Solis Healthcare, DB Finance and Legacy Homes.

Mr. Falbaum serves on several private boards including North Louisiana Bidco, Chairman of Louisiana Chapter of the young Presidents Association (YPO), Executive committee of the Western Area Board of YPO and past board member of Association of Walls and Ceilings Industry (AWCI) and Ceiling and Interiors Construction Association (CISCA). His community involvement also includes Past Chair of Sci-Port Discovery Center, Willis-Knighton Health System Board of Trustees, Committee of 100, Louisiana State Committee of 100, Public Affairs Research Council, Past Chairman of Greater Bossier Economic Development Foundation, Trust Advisor to the Holy Angels Residential Facility and Vice Chairman of the Biomedical Research Foundation. He has also served on the business advisory board for Centenary College, Robinson Film Center and Past President of Shreveport-Bossier Manufacturers Managers Council.

Mr. Rand Falbaum married his high school sweetheart, Susan Adams, in 1981. They have two children, Erin, an Emory University (Atlanta) graduate and Evan, a junior at the University of Alabama (Birmingham). Mr. Falbaum is a licensed pilot with Flight Instructor, Commercial and Airline Transport Pilot ratings and also enjoys flying his own airplane.



Roy Griggs, a native of Meridian, Mississippi, began his career with McDonald's Restaurant following his graduation from Southeast High School in 1971. Mr. Griggs was promoted to manager of the McDonald's Restaurant in 1974; which, at that time, distinguished him as one of the first black managers in Meridian. In 1981, he

was awarded Outstanding Young Man in America. Mr. Griggs received the McDonald's Achiever's Award in 1985. After receiving approval from McDonald's Corporation to own and operate his own McDonald's franchise in 1988, he opened three McDonald's Restaurants in Alabama.

In 1997, Mr. Griggs sold his Alabama franchises and purchased four McDonald's in Shreveport-Bossier. That same year, he was honored with The Ronald McDonald Award, the most prestigious award given to one owner/operator within a region. Mr. Griggs received the award again in 2006. He presently owns eleven McDonald's Restaurants.

Mr. Griggs' past affiliations include Board of Directors of Boys and Girls Club of America, Advisory Board for area schools, Tourism Board of Shreveport-Bossier, Co-Op President for the local McDonald's Owners in Shreveport-Texarkana, as well as city and county industrial boards. Among other offices, he has served as Vice Chair of Minority, Women and Small Business of Greater Shreveport Chamber of Commerce, Caddo District Chairman and Vice Chair of Membership for Boy Scouts of America (BSA). He also served as Norwela Council BSA Finance Chair for the Scoutreach Program. Currently, Mr. Griggs serves on boards of The Committee of 100, Hal Sutton Foundation, The Independence Bowl Foundation, King 5 of the Krewe of Harambee, Shreveport-Bossier African American Chamber of Commerce, as well as, local and national McDonald's Black Owner/Operator Association.

Mr. Griggs has always been civic-minded which led to his nomination in 1996 as Citizen of the Year in Alabama. The Greater Shreveport Chamber of Commerce recognized Mr. Griggs as 1998 Minority Business of the Year.

Roy Griggs and his wife, Nelva, reside in Shreveport and are active members of The Stonewall Baptist Church in Bossier City. They have six grandchildren. The Griggs have three sons, Delano, who owns two McDonald's; Michael, Disney World Spa Manager; and Tony, sophomore at LSU. Their only daughter, Luchina, serves as Chief Executive Administrator of Griggs Enterprises and plans to become a McDonald's Owner/Operator.



W. Clinton Rasberry, Jr. was born raised in Shreveport, Louisiana. He attended Southfield School and graduated from Byrd High School in 1959. He received his B.A. from Vanderbilt University attended forestry school at Louisiana State University.

Mr. Rasberry is the owner of Crestview Woods, LLP and is the managing partner of Rasberry Commercial Property, Westport Real Estate, Westport Co-Investors and Fairfield Inn & Suites in Addison, Texas. He is a partner in the S & R Hotels and North Louisiana BIDCO. He is also active in the real estate business in Florida and Alabama with hotel interests in North and South Carolina. Mr. Rasberry's past business experience includes president of Forest Park Cemetery, Forest Park West, president of the Shreveport Monument Company and numerous other commercial real estate and hotel enterprises.

W. Clinton "Bubba" Rasberry serves on the Board of Regents of the State of Louisiana, Chairman of the Sci-Port Discovery Foundation, Executive Member of the Louisiana Health Sciences Foundation, as well as, on the board and endowment panel of the Norwela Council of Boy Scouts of America (BSA). He also serves as an Assistant Scout Master of Troop 18, Norwela Council.
